



ASPIRE FCU WEEKEND GETAWAY OFFICIAL PROMOTION RULES

1. NO PURCHASE NECESSARY
2. Eligibility for Promotion: Members who satisfied the defined promotional qualifications throughout the year. The qualifications are outlined in our promotional marketing materials. All entrants must be members in good standing who are 18 years or older, and are U.S. residents.
3. There will be one (1) grand prize winner (the "Grand Prize Winner") selected from among all the Eligible Entries received. By entering, participants acknowledge compliance with these official rules including all eligibility requirements.
